CSC Prestige Athlete Policy



Each policy requirement must be initialled in the box beside it indicating that the Event Coordinator has read, understood and agreed to be responsible for its enforcement.

Requirement #1 – Prestige Athlete Approval

All Athletes must complete the Prestige Application and be approved by the CSC Board.

Requirement #2 – Athlete Membership/Insurance

All Canadian Athletes are registered CSC Members and have submitted their CSC Medical.
All Non-Canadian Athletes have completed a CSC Membership form.
All Non-Canadian Athletes must provide a medical form declaring their fitness to compete at weigh in.
All Non-Canadian Athletes must provide proof of medical insurance coverage at the weigh in.

Requirement #3 – Coaching Requirements

All Canadian and Non-Canadian Coaches are registered CSC Members

Requirement #4 – Promotional Requirements

All Prestige Class Bout must be promoted as ‘CSC Prestige Bouts’
The use of the following terms – or variation of these terms – is strictly prohibited:

PRO, Professional, PROAM, Prize-Fight, Prize Contest

Requirement #5 – Awards Requirements

Providing purses to Prestige Class athletes is strictly prohibited
If Belts are provided to winners - only CSC/WAKO Belts are permitted

Requirement #6 – Sanctioning Fee

The Sanctioning fee must be received by the CASK office with the application 60 days in advance.

- a. K1 – 3 round; LK/FC – 5 round - \$350
- b. K1 – 4 round; LK/FC – 7 round - \$450
- c. K1 – 5 round; LK/FC – 9 round - \$550
